1. AIMS AND OBJECTIVES :-

Commerce training college, M.C.A., B.C.A., Computer education in Software & Hardware, Networking, DTP, Auto Cadd and English Spoken Class, Tuition, Self Employment, Evening College, Vocational Training center, etc.

b. To open School of Nursing, college of Nursing, Pharmacy, Paramedical, Industrial training institute, Residential School, Law, Medicine, Sanskrit Medicine, D.Ed., CPD B.E.D., Teachers training college, B.B.M, M.B.A., Dental College, Deiploma training College, Engineering and other educational institutions.

- c. To conduct health awareness programmes camp, organize camps blood donations camps.
- d. To organize training camps in the field of industry, agriculture, sericulture, Horticulture, etc.
- e. To encourage fine arts and cultural activities in Music, Dance and Drama and also sports activities.
- f. For the purpose of the Society may establish educational institutions fo different kinds of different levels as and when they are required.
- g. To establish libraries, hostles, boarding house free or otherwise to facilitate the promotion of student community.
